#### A) 2013 – 2014 CIP Financing

Administrator Doneux shared at the December 19, 2012 Board meeting the 2013 Budget and Levy was adopted that included project financing for projects through bond proceeds. The District has not issued bonds for capital improvements since 2007 for the Arlington Pascal Stormwater Improvement where \$1,550,000 bonds were sold to cover the District's share of that Project.
