Your voice needed to improve Como Lake

Saint Paul, Minn. (July 24, 2018) – Capitol Region Watershed District (CRWD) seeks public input to help develop plans for a healthier Como Lake. The Como Lake Strategic Management Plan (2002) has served as the blueprint for efforts to protect, manage and improve the lake. The plan is being updated to reflect the latest science, innovations in stormwater management and the community’s goals for the lake. CRWD and partners have installed numerous projects in recent years to capture nutrient-laden runoff and allow it to soak into the ground. Lake area residents also coordinate neighborhood leaf clean-ups to reduce excess nutrients flowing into the lake. Excess nutrients from decomposing leaves and grass clippings fuel algal growth leaving the lake green, and in some cases, smelly in the summertime. Despite all this work, water quality improvements are still needed.

“There is a remarkable power in a bunch of volunteers banding together to clean up the lake by sweeping leaves from the streets. Doing these small things may seem insignificant, but when we as a community do them together, it makes all of the difference in the world.” -Mike Ireland, Como Area Resident

The updated Como Lake Management Plan will be developed through an adaptive process, combining the best science with community input to create a shared understanding of the historical and current conditions, as well as a vision of what a healthy Como Lake looks like. CRWD is developing a Public Advisory Group (PAG) to aid in this process. This is an important opportunity for residents who care about the lake to help shape its future.

The first of three meetings is scheduled for Thursday, August 9, from 6-8 pm at Como Lakeside Pavilion. The second meeting will be held in November 2018, and the third in February 2019.
