Ms. Berry mentioned that they are still working on encouraging current and new participants. Ms. Lilly asked about the strategy for rental properties. Ms. Berry replied that Hamline Midway discussed having tools available to borrow residents who might live in apartments. Ms. Braun asked about an event for her area. Mr. Weil asked about signage near the drain. Mr. Duerre asked about the spring sediment comment on the brochure. Ms. Berry replied and there was much discussion.
