A) CAC History Report Presentation. (Arbeit)

Mr. Arbeit presented a history of Como Lake and CRWD. Mr. Arbeit chronicled Como Lake going back to the 1800's, progressing from an agricultural area to a resort area to a municipal park and the resulting water quality issues along the way. He described the issues with stormwater, geese and the lake being loved to death that led to such a degradation that neighbors around the lake petitioned to form a watershed district and resulted in the formation of CRWD.

Mr. Arbeit then highlighted actions taken by CRWD and partners to greatly improve the situation around Como Lake.
