## V. District Initiatives for Review, Comment, and Recommendations

A) TBI Detailed Water Quantity and Water Quality Modeling (Zwonitzer)

Mr. Zwonitzer and Mr. McKinney gave an update on the computer modeling project for the Trout Brook Storm Sewer Interceptor and the Trout Brook subwatershed. This model expands on previous modeling and provides much more detail on water quantity (XPSWMM) and water quality (P8) issues. It will identify flooding potential and estimate pollutant loading in the watershed. This model was developed with the assistance of Barr Engineering and 75% of the project was covered by a FEMA grant. The water quantity model identifies potential flood areas and does a flood prioritization analysis based on a composite flood score and the social vulnerability index. Water quality modeling evaluates existing and future BMPs and identifies where water quality improvements may be most beneficial. This modeling will provide staff with information to better understand and address flood and water quality issues in the watershed.

### VII. Project and Program Updates

A) Facility Management Program Update (Kelley)

Mr. Kelley gave an update on the CRWD Stormwater Facility Management Program Plan. CRWD has many stormwater treatment facilities in the District with more on the way. All of them require some degree of O&M to keep them viable and operating correctly. Many of the local government facilities that own these facilities have limited finances, staff, and expertise to maintain these facilities and keep them operating correctly. CRWD has developed this plan to assist public partners with the operation and maintenance of stormwater facilities. The plan outlines three approaches for assisting public partners. Approach 1 is Pooled BMP Maintenance Services for small facilities who are then invoiced for the services. Approach 2 is Regional Facility Maintenance Assistance for regional facilities owned by LGUs. Approach 3 is Regional Facility Ownership where in rare cases CRWD will consider ownership of

regional facilities that are of high priority to CRWD. Overall, partners have expressed support for the program.
