A) Climate Resiliency Framework Project Charter (Zwonitzer)

Mr. Zwonitzer provided an overview of CRWD's Climate Resiliency Framework Project Charter. This charter will serve as a guide for the Board and staff as to the project and program changes needed to mitigate the impacts of climate change. It will focus on protecting stormwater infrastructure and water resources in the District from the impacts of climate change. The charter will include project development, scoping, internal review, partner buy-in, and CAC and Board input. Desired outcomes include developing actions/recommendations for each program area, alignment with existing plans, consideration and incorporation of CRWD's DEI goals, engaging and collecting feedback from partners and stakeholders, evaluation of risks to natural resources and infrastructure, review of existing local climate data and identifying anticipated changes and determine the need for future investigations.
