V. District Initiatives for Review, Comment, and Recommendations

A) Review Chloride Management Plan Project Charter and Request for Qualifications (Wein)

Ms. Wein reported on the Chloride Management Plan Project Charter and Request for Qualifications. CRWD has seen an increase in chloride concentrations in area lakes, primarily due to road salt, and has identified a need for a Chloride Management Plan to prevent and reduce chloride pollution in CRWD water bodies. Staff intend to initiate a Request for Qualifications to select a consultant to work with them in developing the plan. The plan is expected to be finalized by December 2024.

VI. CAC Initiatives

A) CAC Reinvigoration Project (Armstead)

Ms. Armstead reported on the CAC Reinvigoration Project. The CAC is a group of interested CRWD residents who meet monthly to hear about District issues and projects, advise and assist the Board of Managers, and serve as a communications link between residents and the Board. Attendance at the CAC meeting and participation in other activities have been declining recently, so it is thought that the CAC needs a refresher. The current makeup of the CAC is primarily older Caucasians, which does not reflect the makeup of the District. Recruiting additional members to the CAC is desired, which will better reflect the district's diversity and provide new energy to assist CRWD in its initiatives. To help meet these goals, staff have prepared a draft of the CAC Reinvigoration Project, which Ms. Armstead presented to the CAC and asked for questions and comments.

B) Debrief on Watershed Awards Ceremony (Armstead)

Ms. Armstead asked for comments from CAC members who had attended the CRWD Watershed Awards Ceremony on February 1, 2024.
